The undersigned incorporator for the purpose of forming a nonprofit corporation under the laws of the State of California hereby certifies:

### ARTICLE 1. NAME

The name of the corporation is FURRY FRIENDS FOUNDATION.

### ARTICLE 2. NONPROFIT PUBLIC BENEFIT CORPORATION

This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Public Benefit Corporation Law for public or charitable purposes.

#### ARTICLE 3. AGENT FOR SERVICE OF PROCESS

#### ARTICLE 4. SPECIFIC PURPOSE

The specific purpose of the corporation is to provide services to children who are seriously ill or confined by offering them companionship with animals.

#### ARTICLE 5. TAX EXEMPT STATUS UNDER IRC \$501(c)(3)

A. The corporation is organized and operated exclusively for charitable purposes within the meaning of \$501(c)(3) of the Internal Revenue Code.

- B. Notwithstanding any other provision of these articles or the bylaws, the corporation shall not carry on any other activities not permitted to be carried on (i) by a corporation exempt from federal income tax under \$501(c)(3) of the Internal Revenue Code, or (ii) by a corporation contributions to which are deductible under \$170(c)(2) of the Internal Revenue Code.
- C. No substantial part of the activities of the corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of any candidate for public office.

# ARTICLE 6. ASSETS IRREVOCABLY DEDICATED TO CHARITABLE PURPOSES

The property of the corporation is irrevocably dedicated to charitable purposes and no part of the net income or assets of the corporation shall ever inure to the benefit of any director, officer or member thereof or to the benefit of any private person. Upon the dissolution or winding up of the corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of the corporation shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for charitable purposes and which has established its tax exempt status under \$501(c)(3) of the Internal Revenue Code.
